


#### Mirabaud - Equities Swiss Small and Mid I cap. CHF



#### Cumulative Returns (%)






#### Mirabaud Swiss Alpha Plus Q dist. CHF







#### Mirabaud - Equities Asia Ex Japan I cap. USD



#### Cumulative Returns (%)








#### Mirabaud - Discovery Europe I cap. EUR







#### **Cumulative Returns (%)**






#### Mirabaud - UK Equity High Alpha I cap. GBP







#### Cumulative Returns (%)






#### Mirabaud - Global Strategic Bond Fund I cap. USD

#### Cumulative Returns (%)





#### **Cumulative Returns (%)**







#### **Cumulative Returns (%)**






#### Mirabaud - Convertible Bonds Europe I cap. EUR


